*Care and Maintenance Fund Contribution: As required under the Funeral, Burial and Cremation Services Act, 2002 and Ontario Regulation 30/11, the amounts will be contributed to an irrevocable trust fund known as the Care and Maintenance Fund/Account. Interest income from this fund is used to cover care and maintenance expenses of the cemetery in perpetuity.

**As required under the Funeral, Burial and Cremation Services Act, 2002, the amounts must be paid to the cemetery operator before a marker is installed. After each marker installation, the amount will be contributed to an irrevocable trust fund known as the Care and Maintenance Fund. Interest from the fund will be used to cover expenses for the care and maintenance of markers and monuments in perpetuity.
